## ACI Diploma *and* ACI Diploma New Version

ACI – The Financial Markets association has announced a revision to the **ACI Diploma** syllabus and examination offerings for 2020.

### Examination - ACI Diploma (September 2017 syllabus)

The currently available syllabus and examination format will remain available to candidates for at least six months. This examination based on the ACI Diploma (September 2017 syllabus) contains 107 multiple choice test questions to be answered in three hours with theory questions worth 1 mark and calculation questions 2 marks.

There are six core subject areas (divided into 18 theory and calculation question baskets) in the **ACI Diploma (September 2017 syllabus)**: Foreign Exchange, Money Markets, Fixed Income, Derivatives, Market Analysis, Risk Management

### Examination - ACI Diploma New Version

The **ACI Diploma New Version** syllabus and examination will be available concurrently with the **ACI Diploma (September 2017 syllabus)** but differs in the number and title of topics and its examination format. In the **ACI Diploma New Version** candidates will be asked 100 multiple choice test questions to be answered in three hours with all questions worth 1 mark each.

There are five core subject areas in the **ACI Diploma New Version**: Financial Markets Environment, Foreign Exchange, Rates (Money and Interest Rate Markets), FICC (Fixed Income, Currency and Commodities) Derivatives, Financial Markets Applications.

Both computer-based exams will be offered in selected test centres all over the world.

### Differences between the **ACI Diploma (September 2017 syllabus)** and **ACI Diploma New Version**

- There are 107 questions in the ACI Diploma and 100 questions in the ACI Diploma New Version
- There are 18 Topic Baskets in the Examination Procedure of the ACI Diploma and 5 Topic Baskets in the Examination Procedure of the ACI Diploma New Version
- There are no Topic Baskets exclusively with calculations in the ACI Diploma New Version
- The ACI Diploma New Version has no learning objectives for technical analysis and risk management calculations
- The ACI Diploma New Version does not have additional content when compared to the ACI Diploma
- There are no different marks per question in the ACI Diploma New Version (each correctly answered question is awarded with one mark)

ACI advise that the **ACI Diploma (September 2017 syllabus)** question database has been reviewed and some new questions added but that there are no new question types. Both examination formats will co-exist for a minimum period of 6 months and then the **ACI Diploma (September 2017 syllabus)** will be officially retired with the exact date to be announced in early 2020.
